

## Propane Homeowner Building/Remodeling Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE CHANCE OF WINNING.

Sweepstakes ends 12/15/2019.

**ELIGIBILITY:** The sweepstakes is only open to those who are current homeowners at the time of entry and legal U.S. residents and 18 years of age or older (or 19 years of age or older for residents of AL and NE) as of January 1, 2019. Employees of the Sponsor, the Sponsor Affiliates including authorized distributors of the Sponsor's products, or any of the members of their immediate family (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren) or same household of each are not eligible to participate. This Sweepstakes is void in the states of Florida and New York. This sweepstakes is void in Puerto Rico, Guam, the Virgin Islands, U.S. Territories and Possessions, and where prohibited or restricted by law, and is subject to all applicable federal, state and local laws.

**HOW TO ENTER:** Enter the Sweepstakes beginning at 12:00:01 AM ET 1/14/2019 and ending 11:59:59 PM ET 12/15/2019. Entrants may visit the Propane Homeowner Building/Remodeling Sweepstakes website online at <http://www.propane.com/appliance-giveaway> and complete the entry form including all requested information. Entries must be received by 11:59:59 PM ET 12/15/2019 and must be complete in order to be eligible. Online entries generated by script, macro, or other automated means are void. Normal Internet access and usage charges imposed by entrant's online service will apply. Neither the Sponsor nor the Sponsor Affiliates assume any responsibility for incorrect or inaccurate capture of entry information, including, but not limited to, technical malfunctions, human or technical errors, printing errors, lost/delayed/garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software, or any combination thereof.

Limit One Entry per person regardless of the method of entry.

**PRIZES AND APPROXIMATE VALUE:** Four (4) Grand Prizes: Package of propane-fueled home appliances. Each package consists of: one water heater (approximate value \$1,700), one backup generator (approximate value \$3,000), one range/oven (approximate value \$1,200), one furnace (approximate value \$1,000), and one grill (approximate value \$750). Approximate total value of each package is \$8,000 including delivery of appliances to winner's home. One Grand Prize will be awarded each quarter during 2019. Total Approximate Value of all prizes: \$32,000. Appliance brands and models will be determined based on availability through the local propane supplier. Sponsor reserves the right to substitute prize with another prize of equal or greater value.

**PRIZE WINNER SELECTION/NOTIFICATION:** Winner will be selected in a random drawing, on or about the following dates from among all eligible entries received by the drawing date: March 18, 2019; June 17,

2019; September 16, 2019; December 16, 2019. Drawings will be conducted by the Administrator, whose decisions are final and binding on all matters relating to this sweepstakes. Odds of winning are dependent upon the number of eligible entries received.

Potential winners will be notified by registered mail at the address of the home specified on the entry form and will be required to (a) specify the name, address and phone number of their local area propane supplier, (b) complete, sign, and return a notarized Affidavit of Eligibility/Release of Liability, (c) return a completed and signed IRS form W-9 and (d), where legal, sign a Publicity Release within 14 days of notification attempt or prize will be forfeited and an alternate winner selected. If any notifications or prizes are returned as undeliverable after one attempt and/or the Prize winner's affidavit and release is not returned to the Sponsor within 14 days of date of prize notification, the winner may be disqualified and an alternate winner may be selected. Authorized account holder is defined as the natural person who is assigned to an email address by an Internet Access provider, Online Service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Sponsor reserves the right at their sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the sweepstakes or website; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person.
