

GIE Trailer Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE CHANCE OF WINNING. Sweepstakes ends 10/18/2019.

ELIGIBILITY: The sweepstakes is only open to those who are legal U.S. residents who are professional landscape contractors and 18 years of age or older (or 19 years of age or older for residents of AL and NE) as of October 1, 2019. Employees of the Sponsor, the Sponsor Affiliates including authorized distributors of the Sponsor's products, or any of the members of their immediate family (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren) or same household of each are not eligible to participate. This Sweepstakes is void in Puerto Rico, Guam, the Virgin Islands, U.S. Territories and Possessions, and where prohibited or restricted by law, and is subject to all applicable federal, state and local laws.

HOW TO ENTER:

There are two ways to enter the Sweepstakes:

Pre-entry into the Sweepstakes will begin at 12:00:00 AM ET 9/7/19 and end 10/16/19 at 12:00:00 AM ET. Pre-entrants must sign up to receive PERC's The Cut e-newsletter and provide a valid, active email address by completing the form on <https://Propane.com/gie-expo-2019/>. Entries must be received by 12:00:00 AM ET 10/16/19 and must be complete in order to be eligible.

Enter the Sweepstakes in person beginning at 3:00:00 PM ET 10/16/2019 and ending 3:59:59 PM ET 10/17/2019. Entrants must visit the Propane Education & Research Council (PERC) booth, Booth 7094, at the 2019 GIE+Expo trade show event located in the Kentucky Exposition Center in Louisville, Kentucky, and complete the required entry process. Visitors may submit one entry during their visit to the booth. One entry form may be submitted after the visitor signs up to receive PERC's The Cut e-newsletter and provide a valid, active email address. Entries must be received by 3:59:59 PM ET 10/17/2019 and must be complete in order to be eligible. All entries must be submitted at the PERC booth using the process specified by PERC and staff at the booth.

All other forms of entry are void. Neither the Sponsor nor the Sponsor Affiliates assume any responsibility for incorrect or inaccurate capture of entry information, including, but not limited to, technical malfunctions, human or technical errors, printing errors, lost/delayed/garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software, or any combination thereof.

No purchase is necessary to enter or to win.

Entrants must be present at the PERC booth at the time of drawing, 4:00:00 PM ET on 10/17/19, to be eligible to win.

Limit One Entry per person regardless of the method of entry.

PRIZES AND APPROXIMATE VALUE: One (1) Grand Prize: 16' Big Tex 70LR Tandem Axle Landscape trailer, with lockable storage box and tool racks, one (1) Exmark Lazer Z S-Series Propane, one (1) Spartan RTHD 61" ZTR mower, trailer accessories consisting of one (1) Stihl FSA 56 Cordless battery-powered string trimmer, one (1) Stihl BGA 56 Cordless battery-powered blower, one (1) Igloo water cooler, twenty-five

(25) safety vests, and twenty-five (25) pairs of work gloves. Approximate value is \$28,000.00. Sponsor reserves the right to substitute prize with another prize of equal or greater value. Unclaimed prizes will not be awarded.

PRIZE WINNER SELECTION/NOTIFICATION: The winner will be selected in a random drawing, at 4:00:00 PM ET 10/17/2019, or as soon thereafter as practical, from among all eligible entries received. Drawing will be conducted by the Sponsor, whose decisions are final and binding on all matters relating to this sweepstakes. Entrants must be present at the PERC booth at the time of the drawing in order to win. The individual whose name is drawn will be announced verbally and will have one minute to claim the prize. If the individual whose name is drawn does not claim the prize within one minute, an alternative name will be drawn from the remaining entries and that individual will have one minute to claim the prize. Additional names will be drawn if needed until the prize is claimed within the designated time period. Odds of winning are dependent upon the number of eligible entries received.

Winner will be required to operate the mowers on a minimum of 30 number of days during the one-year period beginning on the day on which the mowers are delivered to the winner. At PERC's request, the winner will be required to provide feedback to PERC via email or phone on their experience with the mower. Feedback to a maximum of 4 requests during the year is required.

Winner will be required to complete and submit IRS Form W-9 to provide taxpayer identification. Sponsor will submit IRS Form 1099-MISC with prize details.

PERC will arrange for and cover all costs for delivery of the prize to the winner. Additionally, PERC will provide advice to help the winner set up a fueling contract. The winner will be responsible for contacting the fuel provider and meeting all requirements of the fueling contract.
